Process of addressing to grievances of faculty/staff members of the institution

- An aggrieved faculty/staff member of the Institution may send his/her complaint addressed to the Chairperson, GRC.
- The GRC will send its report with recommendations, if any, to the Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur and a copy thereof to the aggrieved faculty/staff member, within a period of 15 days from the date of receipt of the complaint.
- In case faculty/staff is not satisfied with the decision of Grievance Redressal Committee, he/she may appeal to the Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur for redressal of his/her grievances
- The University level Grievance Redressal Cell established by the University shall address such grievances and settle the matter at University level.
